







# **Becoming Accredited: For Institutions Abroad**

**Free-standing institutions abroad** interested in exploring U.S. accreditation are advised to work closely with Commission staff. NECHE's criteria for consideration include the following requirements, among others: that the institution be American-style, that it be independent (non-governmental), that academic programs and degrees are comparable to those offered in the U.S.; that the institution has a governing board including representation of the public interest; and that administration, faculty and professional staff collectively have significant experience in American higher education.

#### **Requirements of Affiliation for Free-Standing Institutions Abroad**

The New England Commission of Higher Education will consider for eligibility interested independent institutions of higher education that declare themselves to be American-style institutions.


To be declared eligible to apply for candidacy with the New England Commission of Higher Education, an institution operating entirely outside the United States and its territories must meet the following requirements. Candidate and accredited institutions must continue to fulfill these requirements as specified in the *Standards for Accreditation*.

#### Independence


1. The institution has formally adopted a statement of mission, which demonstrates that the fundamental purposes of the institution are educational, and which is also appropriate to a degree-granting institution and appropriate to those needs of society it seeks to serve;

#### 24 Requirements:

- Independence
- American Style
- Educational Mission and Purposes
- Resources
- Transparency



Candidacy: Institution demonstrates that it is in "substantial" compliance with Standards for Accreditation in 5 years

Bangladesh	Eligibility visit completed; NECHE determined not yet eligible; requested additional information	Submit additional information within 1 year; NECHE will reconsider if eligible to apply for candidacy
France	Eligibility visit completed; NECHE determined not yet eligible; requested additional information	Submit additional information within 1 year; NECHE will reconsider if eligible to apply for candidacy
France	Eligibility visit scheduled in Fall	NECHE to approve eligible for candidacy
Greece	Candidacy Visit in Fall	5 years to complete candidacy
Kurdistan	Meeting with NECHE President	Draft Eligibility Report; Staff visit
Lebanon (2)	Staff Visit completed	Submit Eligibility Report; Schedule 3 person visit
Lebanon	Initial Accreditation	Interim report in 2.5 years; Comprehensive evaluation in 5 years
Morocco	Initial Accreditation	Interim report in 2.5 years; Comprehensive in 5 years
Pakistan	Staff visit scheduled in November, 2019	3 person visit
Pakistan	Staff reviewing draft Eligibility Report	Staff Visit
Saudi Arabia	Staff reviewing draft Eligibility Report	Staff Visit
